 2. The School is required to apply on online for further extension of affiliation along with the requisite fee and other do Rule 10.3 of Affiliation Bye Laws, 2018.
 3. The school will also abide by the conditions prescribed, if any, by the State Government concerned as mentioned in appendix III issued by District Education Officer (DEO) /equivalent officer
 4. The school should ensure the strong governance and management of its activities in way of comprehensive and qua in way of curriculum planning, infrastructure, resources, physical education, staff development and other co-curricul
 5. The school should go through the provision of **Affiliation and Examination Bye Laws and keep a copy there of** purpose and also advised to visit CBSE websites i.e. <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates. T expected to see all circulars on these CBSE websites regularly.
 6. The school will strictly adhere to all rules regarding safety of students including Fire fighting and Transportation, etc will provide adequate facilities for potable drinking water and clean healthy and hygienic toilets with washing facilitie girls separately in proportion to the number of students. The school will ensure that Fire, Building, health and sanita drinking water certificates are renewed from time to time, as per norms.

16. The Manger and the Principal of the school shall be jointly responsible for the authenticity of the online/offline docur information/data submitted by the School to the Board.

22. The school shall renew all mandatory safety certificate i.e Safe Drinking Water & Health and Hygiene certificate, Fire Certificate and Building Safety Certificate from concerned Govt authorities time to time

The school shall also maintain record of certificate, compliances, data and other records/information and shall be ful produce all such records before Board and appropriate Government Authorities when asked for, failing which necess be taken as per Affiliation-Bye-Laws of the Board.
